1. Determination of the Final Redemption Amount:

The Notes will be redeemed on the Maturity Date. The Final Redemption Amount will be calculated by the Calculation Agent depending on the performance of the **DAX[®] Index** as follows:

- a) If, on the Observation Date, the Final Price of the Index is higher than the Base Value, then the Final Redemption Amount will be a) the Notional Amount plus b) the Additional Amount which will be calculated in accordance with the following formula:

In its capacity as sole owner of all rights to the Index and the Index Trademark the Licensor has solely licensed to the issuer of the financial instrument and its affiliates the utilization of the Index and the Index Trademark as well as any reference to the Index and the Index Trademark in connection with the financial instrument."
